

Official Rules for the Bluebird Banter Pick 6 Contest

No Purchase Necessary. A Purchase will not Increase Your Chances of Winning.

- Eligibility:** The Bluebird Banter Pick 6 Contest (the “Contest”) is open only to legal residents of the United States and Canada (excluding Quebec) who are at least eighteen (18) years of age. Employees of Vox Media, Inc. or other companies associated with the Contest, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee, are not eligible to enter.
- Sponsor:** The Contest is sponsored by Vox Media, Inc., 1740 N Street, NW, Washington, DC 20036 (“Sponsor”).
- Agreement to Official Rules:** By entering the Contest, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor’s decisions, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- Entry Period:** The Contest begins at 12:05 PM ET on May 13, 2012 and ends at the beginning of MLB play on May 20, 2012. Entries submitted before or after the Entry Period will not be eligible. Sponsor’s computer is the official time-keeping device for the Contest.
- How to Enter:** Visit <http://pick6.sbnation.com>, follow the instructions provided on the website, and simply play Pick 6 to enter. Choose “Bluebird Banter” as your website to compete against other Bluebird Banter contestants. Your daily Pick 6 scores will be calculated, recorded and compared to the Bluebird Banter competition. Contestants who do not select Bluebird Banter as their website and do not compete against other Bluebird Banter contestants specifically are not eligible for this Contest. There is a limit of one (1) entry per person/e-mail address. Entries will not be acknowledged. Individuals who choose to play Pick 6 but do not want to participate in the Contest may opt out of the Contest by sending an email notification to Cory.Williams@sbnation.com. If you currently play on another blog Leaderboard and wish to join the Bluebird Banter Leaderboard for the purposes of competition, you must email support@sbnation.com two (2) days in advance of start of the Contest to be deemed eligible.
- Selection of Winners:** There will be two (2) winners selected each week (with the week running from Monday, May 14, 2012 through Sunday, May 20, 2012). The first winner will be the entrant who scores the highest single point total for a given day of the week on the Bluebird Banter Leaderboard (e.g. if an entrant scores 120.6 points on a Tuesday and that is the highest single point total on the Bluebird Banter Leaderboard out of all days of the week, that entrant will be deemed the winner). The second winner will be the entrant who is the top overall winner on the weekly Bluebird Banter Leaderboard (aka, scores the highest collective overall score for the week). In the event of a tie, all tying entrants will be deemed winners. The odds of being selected depend on the number of entries received and the performance of each entrant.

7. **Notification and Requirements of Potential Winners:** Sponsor will attempt to notify potential winners within five (5) business days of the date of selection. If a potential winner does not respond within five (5) business days after the notice is sent, the Sponsor will select an alternate potential winner in his/her place according to the Judging Criteria. Only three (3) alternate potential winners will be contacted. Except where prohibited, a potential winner may be required to complete and return an affidavit of eligibility and liability/publicity release. If a potential winner is a minor, his/her parent or legal guardian will be required to sign the documents on his/her behalf. If a potential winner fails to sign and return these documents within the required time period, an alternate potential winner may be selected in his/her place according to the Judging Criteria. Only three (3) alternate potential winners may be contacted.
8. **Prize(s):** Each winner will receive an official Pick 6 SB Nation t-shirt worth approximately twenty USD/CAD (\$20). A winner is responsible for paying any applicable income taxes and any and all other costs and expenses not listed above. Any prize details not specified above will be determined by Sponsor in its sole discretion. A prize may not be transferred and must be accepted as awarded. You may not request cash or a substitute prize; however, Sponsor reserves the right to substitute a prize with another prize of equal or greater value if the prize is not available for any reason, as determined by Sponsor in its sole discretion.
9. **General Conditions:** In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, Sponsor may, in its sole discretion, either: (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules; or (b) award the prize(s) according to the procedures set forth above from among the eligible entries received up to the time of the impairment. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication by Sponsor. In the event of a dispute as to any online entry, the authorized account holder of the e-mail address used to enter will be deemed to be the participant. The “authorized account holder” is the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted e-mail address. The Contest is subject to federal, state, and local laws and regulations and is void where prohibited.
10. **Release and Limitations of Liability:** By participating in the Contest, you agree to release and hold harmless Sponsor, its parent, subsidiaries, affiliates, and each of their respective officers, directors, employees, and agents (the “Released Parties”) from and against any claim or cause of action arising out of participation in the Contest or receipt

or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Contest; (b) technical errors related to computers, servers, providers, or telephone, or network lines; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Contest or the processing of entries; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use of any prize. You further agree that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Contest, and in no event shall the Released Parties be liable for attorney's fees. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

11. **Privacy and Publicity:** Any information you submit as part of the Contest will be used for purposes of this Contest and treated in accordance with Sponsor's [Privacy Policy](#). Except where prohibited, participation in the Contest constitutes an entrant's consent to Sponsor's use of his/her name, likeness, voice, opinions, biographical information, and state of residence for promotional purposes in any media without further payment or consideration.
12. **Disputes:** Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Washington, DC. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of Washington, DC, without giving effect to any choice of law or conflict of law rules (whether of Washington, DC or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Washington, DC.
