Upon my arrival I observed the defendant handcuffed and being held onto by D/S STEETER. He walked him towards my patrol vehicle and advised the defendant to gt into my patrol vehicle multiple times and the defendant kept stating "Do you know who I am, you don't know anything about my problems" D/S Stickney again asked him to sit in my patrol vehicle and he still did not comply. D/S Muller advised me that he was in handcuffs due to him failing to follow his orders and that he kept running out in the road with his hands up. I then asked the defendant to get into my patrol vehicle and he stated "Famek you" do you know who I am, I asked him several times to sit in my patrol vehicle and he failed to comply with my orders. I then lifted his left hand to gain pain compliance and he then pushed off the vehicle into me. I then delivered 3-4 knee spikes into his left thigh muscle and the defendant fell into the vehicle. I then shut the door and made contact with D/S Mass who advised me that he observed the vehicle on the side of the road smoking from the engine compartment. He made contact with the driver who was later identified by his valid Florida DL as Jose Miguel Cabrera, while speaking with him he detected a strong odor of an alcoholic beverage coming from his breath when he spoke, his eyes where bloodshot and watery and his speech was

cented and heavily slurred. He then advised me that he asked Jose who was with him and he stated "I am going to fushing kill him" D /S Mass did not see anyone else in the vehicle or in the area. D/S Mass then advised me that he observed Jose pick up a bottle of James Buchanan's Scotch whisky and start drinking it. He then advised me that he asked for his ID and Jose handed him a passport and Jose got out of the car and starting walking into the

roadway putting his hands up. D/S Meder then advised me that he ordered Jose multiple times to get out of the roadway and after a few times he complied but would wander out to the road again. He also advised me that he instructed Jose to put his hands behind his back several times and at times he would but he would then put them down and head towards the roadway.

Sports Towing responded to the scene and towed Jose's vehicle to their lot for safekeeping.

I transported Jose to the St. Lucie County Jail, while traveling to the jail a strong odor of an alcoholic beverage emanated within my vehicle that was not there prior to Jose being put inside.

At the St Lucie County Jail I had D/S Over read Jose implied consent from my pretext card. Jose refused to submit to a lawful test of his breath.

I issued Jose Miguel Gabrera Florida DUI citation 3093-XEF for being in actual physical control of a motor vehicle while his normal faculties where impaired. The keys to the vehicle where located in the ignition. I issued him Florida citation 1848-GNU for open container of alcohol in motor vehicle, driver cited.
